For more beverages, The Loft is close by. On the top floor of the L.A. Foster Student Center, the café offers a variety of coffee, smoothies, and snacks to purchase.





HLGU Roland Library Community Borrower Membership

A community borrower membership entitles the member to check out books from the HLGU Roland Library, request interlibrary loans, and ask for reference assistance.

If library computers are not in use by students, the HLGU Roland Library staff may allow a community borrower member the use of a computer for educational purposes only. Computer use by a community borrower member is limited to one hour per day.

When computer use by community borrower members is allowed, the member is required to present a picture ID and their community borrower membership card. Members must sign in and abide by the Hannibal-LaGrange Computer User Policy.

Please note: HLGU computer accounts and logins are not available to the public. At this time, the Community Borrower Membership does not include MOBIUS privileges (online requesting or visiting check-out).

HLGU Roland Library Community Borrower Membership Cost & Fees

The cost of an HLGU Community Borrower Membership is \$27.50 per year. Memberships are valid for one year from enrollment date.

To enroll, simply complete the registration information sheet available at the Roland Library Circulation Desk. Your membership card will be issued to you. This card must be presented each time you check out an item.
