The information below is updated annually so requirements may be different than what is noted here. Please check individual state websites for accurate information.

<u>Alabama:</u> The Alabama State Department of Education requires an application and submission of forms verifying U.S. citizenship, out-of-state certification, professional educational work experience, and out-of-state testing. <u>Alaska:</u> The Alaska Department of Education and Early Development requires an application and submission of transcripts and test scores. Six semester hours of approved Alaska studies coursework are required before being granted Alaska certification. <u>Arizona:</u> The Arizona Department of Education requires an application and submission of a valid, comparable out-of-state educator certificate, and transcripts. Applicants "who qualify under Certification Reciprocity Rules are exempt from Arizona Educator Exam Requirements". <u>Arkansas:</u> The Arkansas Department of Education requires an online application and submission of official transcripts, copy of out-of-state educator license, proof of passing content area test score and documentation of teaching experience. <u>California:</u> The California Department of Education requires an application and submission of official transcripts, copy of out-of-state teaching license, and proof of passing score on a basic

<u>Colorado:</u> The Colorado Department of Education requires an application and submission of official transcripts, copies of all active and expired teaching licenses, proof of teaching experience and all employment history. <u>Connecticut:</u> The Connecticut Department of Education requires an application and submission of proof of teaching license, a statement of professional experience, official transcripts and proof of testing. <u>Delaware:</u> The Delaware Department of Education requires an application and submission of transcripts, licenses and a verification of teaching experience form. Educators who hold a full and current license in another state will receive a comparable Delaware license. <u>Georgia:</u> The Georgia Department of Education requires an application and submission of official transcripts, verification of citizenship, verification of experience, copy of professional out-of-state certificate, and copy of official score reports required for out-of-state certificate. <u>Illinois:</u> The Illinois State Board of Education requires an application and submission of official transcripts, a copy of a valid, comparable out-of-state license, verification of a bachelor's degree or higher from an accredited institution of higher education. <u>Indiana</u>: The Indiana Department of Education requires an application and submission of official transcripts, valid out-of-state license, official score reports for tests that support an out-of-state license, proof of valid CPR certification and suicide prevention training certificate. <u>Iowa:</u> The Iowa Board of Education requires an application and submission of official transcripts, verification of program completion, valid teaching license from another state, verification of required assessments and experience verification. <u>Kansas:</u> The Kansas State Department of Education requires an application and submission of official transcripts, copy of out-of-state license, educator preparation program verification, and teaching experience verification. <u>Kentucky:</u> The Kentucky Department of Education requires an application and submission of official transcripts and a copy of out-of-state teaching certificate. <u>Minnesota</u>: The Minnesota Department of Education has a tiered licensure structure and requires an application and submission of official transcripts, copy of teaching license,

<u>Mississippi:</u> The Mississippi Department of Education requires an application and submission of a valid out-of-state license, transcripts, and a passing score report on a core subject test required for certification. <u>Nebraska:</u> The Nebraska Department of Education requires an application and submission of official transcripts, verification of completion of a teacher education program from a state approved college or university, verification of passing scores on basic skills and content area tests, and verification of teaching experience. <u>New York:</u> The New York State Education Department requires an application and submission of official transcripts, copy of teaching certificate, verification of completion of approved teacher preparation program, verification of teaching experience and satisfactory passing score on all required exams for initial certificate. Must have a 2.5 cumulative GPA in a Bachelor's or higher degree. Workshops required for certification include Child Abuse Identification and Reporting, Dignity for All Students, and School Violence Prevention and Intervention. For more information go to:
