## 2026-2027 Direct Parent PLUS Loan Instructions

To participate in the Federal Direct Parent PLUS Loan program, a parent borrower needs to complete the steps below. Only biological parents, stepparents, or adoptive parents of undergraduate students may take advantage of this loan program. Please keep this cover letter for your records and be mindful when entering your Name, SSN and DOB (date of birth) information. The information entered for the Parent PLUS Loan and MPN must match the information you provided on the FAFSA.

### Complete Steps:

1. Go to [www.studentaid.gov](http://www.studentaid.gov).
2. From the "Loans and Grants" heading on the main page, select "PLUS Loans: Grad PLUS and Parent PLUS."
3. Under the "Select a borrower type," choose "I am a Parent of a Student." click on Learn More. This will take you to the Log In.
4. On this page, you will need to Log In with your FSA ID and complete the application. The award year is 2026-2027.
5. When determining the amount of the loan you wish to request, you will need to figure in the loan fee of 4.228%. This will be taken off the amount of the loan you request.
6. The loan period can be for the full year or for the semester.
  - Full Year - August 2026 - May 2027
  - Fall Semester Only - August 2026 - December 2026
  - Spring Semester Only - January 2027 - May 2027
  - Summer Semester Only
7. Complete application and submit.

### For an approved application:

1. Complete the MPN (Master Promissory Note). Choose the Option "I'm a Parent of an Undergraduate Student."
2. Submit the attached Direct Parent PLUS Loan Request Form to the Office of Financial Aid.
